Thank you for purchasing this product. Designed to work with your iPod/MP3 player or any audio device, this system provides high quality audio that invites your music to come out and play. Please read the instructions carefully before operating the unit and keep for future reference.

Installing/Replacing Batteries

- 1. Push to open the battery compartment door located on the bottom inside of the unit.
- Insert 4 "AA" R6 (UM-3) batteries (not included), checking that the + and - ends of the batteries match the drawing inside the battery compartment. We recommend the use of alkaline batteries for longer life
- 3. Close the battery compartment cover.

For Best Performance

- We recommend the use of alkaline batteries for longer life.
- . Do not mix old and new batteries.
- Do not mix alkaline, standard (carbon-zinc) or rechargeable (nickel-cadmium) batteries.
- · Batteries are to be inserted with correct polarity.
- · Remove exhausted batteries from the unit.
- Do not attempt to recharge non-rechargeable batteries.
- Remove the rechargeable batteries from the unit before charging.
- The supply terminals are not to be short-circuited.
