iCVBT5 Quick Start Guide

Audio Function



- · Press power button to turn speaker On or Off
- When mirror is On, press and hold for pairing mode, indicated by the blinking BLUE LED
- Select "iHome iCVBT5" on your device's Bluetooth menu to connect



- Press to play / pause Bluetooth audio
- Press to answer / switch between Bluetooth calls
- Press and hold for 2 seconds to end Bluetooth calls
- Press and hold for 10 seconds to activate Siri / Google Now
- Quick double press for next track
- Quick triple press for previous track



Press to lower or raise volume

 Press light button to turn ON Hi/Lo/OFF for the best light brightness




Light turns OFF after 25 minutes to save power.



Charging Devices

- Mirror MUST be connected to AC adapter to enable USB charging from the unit.
 - Connect USB cable (not included) to USB port and the other end to your device to charge.



Other Devices

• Connect non-bluetooth devices with the included cable to the AUX IN jack.



 AUX IN audio works when audio is paused on connected Bluetooth device

GENERAL • Please exercise caution when in use as the mirror is made of glass.

- 1. Water and Moisture The unit should not be used near water. For example: near a bathtub, washbowl, kitchen sink, laundry tub, swimming pool or in a wet basement.

 2. Ventilation The unit should be situated so that its location or position does not interfere with its proper ventilation. For example, it should not be situated on a bed, sofa, rug or similar surface that may block ventilation openings. Also, it should not be placed in a built-in installation, such as a bookcase or
- cabinet, which may impede the flow of air through the ventilation openings.

 Heat The unit should be situated away from heat sources such as radiators, heat registers, stoves or other appliances (including amplifiers) that produce heat.
